## SEX OFFENDER INFORMATION BULLETIN

The Oshkosh Police Department is releasing the following information found on the opposite side of this page pursuant to Wisconsin State Statute 301.45 and 301.46 (Act 440), which authorizes law enforcement agencies to inform the public of a sex offenders release when, at the discretion of the agency, the release of information will enhance public safety and protection.


The individual who appears on this notification has been convicted of a sex offense that requires registration with the local law enforcement agencies. Further, his/her previous criminal history places the offender in a classification level which reflects the <u>potential</u> to offend.

This sex offender <u>has served</u> the sentence imposed on him/her by the courts and has advised officials that he/she will be living in the location on the opposite side of this page. <u>THIS PERSON IS NOT WANTED BY THE POLICE AT THIS TIME</u>. THIS NOTIFICATION IS NOT INTEDED TO INCREASE FEAR; RATHER, IT IS OUR BELIEF THAT AN INFORMED PUBLIC IS A SAFER PUBLIC.

Sex offenders have always lived in our communities but it was not until the passage of Act 440 (which mandates sex offender registration) that law enforcement even knew where they were living. In many cases, law enforcement is now able to share that information with you. Citizen abuse of this information to threaten, intimidate or harass registered sex offenders will not be tolerated. Further, such abuse could potentially end law enforcements ability to do community notifications. We believe the only person who wins if community notification ends is the sex offender, since the sex offenders derive their power through secrecy.

The Oshkosh Police Department is available to help you set up a Neighborhood Watch and to provide you with useful information on personal safety. If you have information regarding current criminal activity of this or any other sex offender, please call the Oshkosh Police Department at (920) 236-5700. In the case of an emergency, call 911.

The offender was convicted in 2014 of EXPOSING GENITALS TO CHILD and convicted of 4 COUNTS OF POSSESSION OF CHILD PORNOGRAPHY. The victim in the first offense was a 15 year old female who was known to the offender. The victims from the other offenses were young girls, unknown to the offender.

## **SPECIAL RESTRICTIONS/REQUIREMENTS:**

- 1.) NO UNSUPERVISED CONTACT WITH MINORS; NO CONTACT WITH VICTIM; NOT TO CONSUME DRUGS.
- 2.) COMPLY WITH STANDARD SEX OFFENDER RULES; COOPERATE WITH ELECTRONIC MONITORING.
- 3.) FACE-TO-FACE CONTACT WITH LAW ENFORCEMENT REQUIRED; COMPLY WITH ALL REQUIREMENTS AND LIFETIME REGISTRANT OF WI SEX OFFENDER REGISTRY.

VERNON OPPERMANN will be HOMELESS in the City of Oshkosh, WI on July 30, 2024. He is on Lifetime GPS and on Probation until 08/08/2030. For more information check www.doc.wi.gov

As of 07/10/24, there are 26,937 registered sex offenders required to register in WI. 6,152 are incarcerated, 6,140 are on active supervision and 14,645 are terminated from supervision. There are 603 registrants in Winnebago County.
