#### **Friday-March 20, 2015**

##### **Juvenile**

A 12 year-old male from Oshkosh was taken into custody for rules violations and transported to shelter care in Oshkosh.

##### **Disturbance-Warrant**

A 26 year-old male from Oshkosh was taken to jail for a child support warrant after he was involved in a non-violent domestic disturbance in the 1700 block of Taft Ave.

##### **Community Policing**

Officers Lehman and Mann mentored at Washington and Traeger Elementary Schools, respectively.

##### **Domestic-Arrest**

A 27 year-old male from Oshkosh was arrested in the 30 block of W. 10<sup>th</sup> Ave. for domestic disorderly conduct and battery after he was involved in a physical altercation with the victim, a 30 year-old female from Oshkosh. He was transported to the Winnebago County Jail.

He was also cited for reckless driving and taken to jail.

#### **Community Policing**

#### **Domestic Arrest**

A 31 year-old male from Oshkosh was arrested for domestic disorderly conduct and battery in the 1000 block of S. Washburn St. after a disturbance with his brother, a 32 year-old from Oshkosh. The 31 year-old was taken to jail.

#### **Disturbance Arrest**

#### **Runaway Follow-Up**

A 16 year-old female runaway from Oshkosh was located by Milwaukee Police. The mother of the 16 year-old attempted to bring her back to Oshkosh, but the juvenile attempted to run again. Oshkosh officers went to Milwaukee and transported the 16 year-old female to Fond du Lac Secure Detention.

#### **Domestic Violation 2nd**

The 27 year-old male previously mentioned in Friday's call for domestic, was arrested for a second time for violating the 72 hour no-contact rule. This was added to his arrest as he is still in jail.
